3. **Training Place:** Indira Gandhi Centre for Atomic Research, Kalpakkam – 603 102
4. **Age Limit** as on date of interview upto 22 years (relaxable by 5 years in the case of SC/ST Candidates and 3 years for OBC candidates)
5. **Period of Training:** As provided in Schedule–I to Apprentice Rules, 1991.
6. **Amount of Stipend:** As notified from time to time by Directorate General of Employment and Training (DGET), Ministry of Labour and Employment, New Delhi.
7. **Selection Procedure:** Selection will be made through walk-in-interview. Eligible and interested candidates should bring filled in application form along with all original and self-attested photo copies of certificates at the time of walk in interview.
8. **General Instruction:**
  - a. The application forms should be accompanied by two recent conduct certificates in original from **TWO** Gazetted Officers.
  - b. No Correspondence will be entertained with the candidates.
  - c. Candidates selected for training will not be allowed to withdraw from training except for reasons, which are beyond their control. Before commencement of the training, the candidates will have to execute a contract of Apprenticeship. Those who willfully absent themselves are liable to refund the whole cost of their training as well as the amount paid as stipend as determined by the Central Apprenticeship Adviser.
  - d. The engagement and training are strictly in compliance with the provisions of the Apprentices Act 1961 and there is no guarantee for employment of the Apprentices on completion of their training.
  - e. Those who have already availed the apprenticeship will not be considered.
  - f. Every Apprentice who has completed the period of training will, on passing a test to be conducted by the National Council for Training in Vocational Trade to determine his proficiency in the designated trade in which he has served as an Apprentice would be given a certificate of proficiency in the trade by the National Council.
